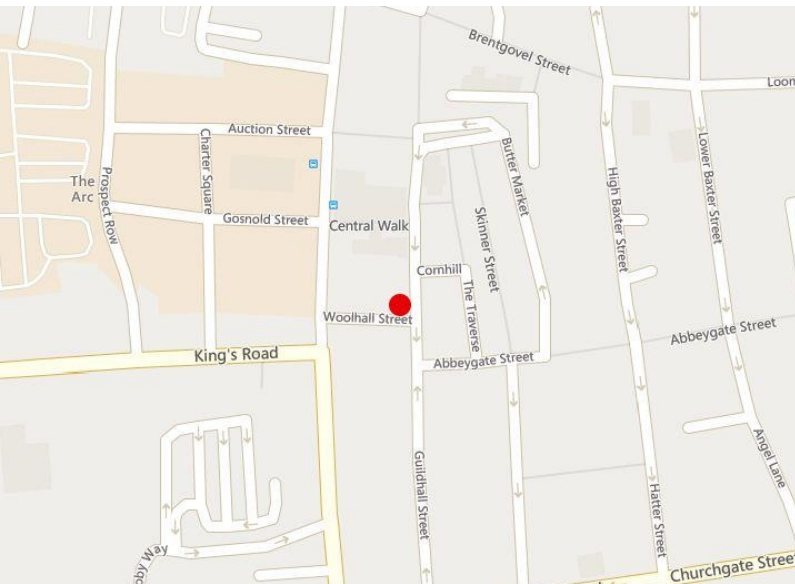
Description
