Description

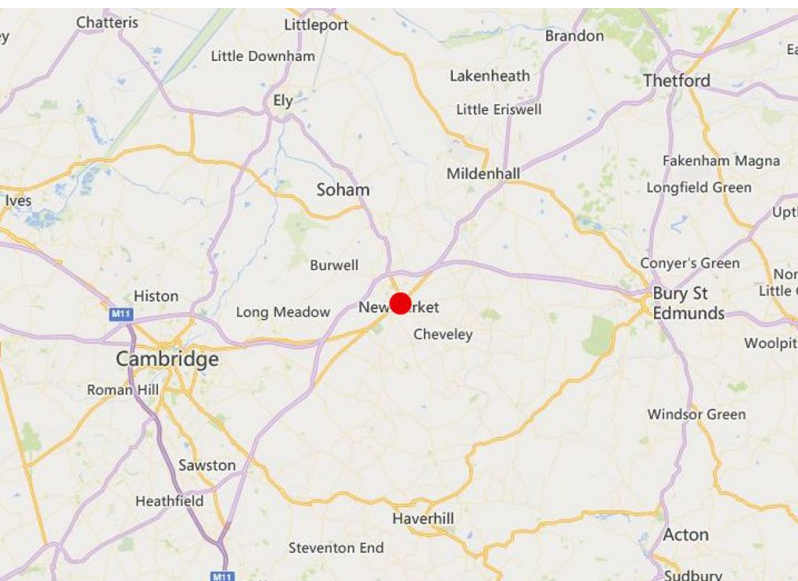
The property is situated in Newmarket, a market town located on the Cambridgeshire/Suffolk border. Newmarket benefits from direct access to the A14, providing direct access to Cambridge, Bury St Edmunds and the wider East Anglia region, with the A11 also offering convenient links to London and the M11 corridor.

The unit comprises three ground-floor rooms with ramped access from the highway, plus three rear storerooms and a vault. The first floor provides male and female WCs and storage, while the second floor includes a kitchen, WCs and a storeroom. The ground floor is fitted with carpeting, a suspended ceiling with inset lighting, and air cooling/heating.
