## Description

Tanner Court is located on Tanner Street opposite the Public Library between two free public car parks on the edge of Thetford town centre. The unit is next door to the pharmacy and is a 2 minute walk from the market place which operates on Tuesdays and Saturdays.

The unit benefits from a naturally lighted shop front area which is visible from across the street and accessible straight from Tanner Street.

The first section of the unit slightly risen by a single step which benefits from a higher ceiling, three stand lights and ceiling to floor glass frontage looking out to the library and pharmacy. The second section includes a countertop, suspended ceiling with inset lighting, while the third benefits from a kitchen area with three sinks, an extractor and preparation area. The unit further includes WC, storage cupboard and radiators throughout.

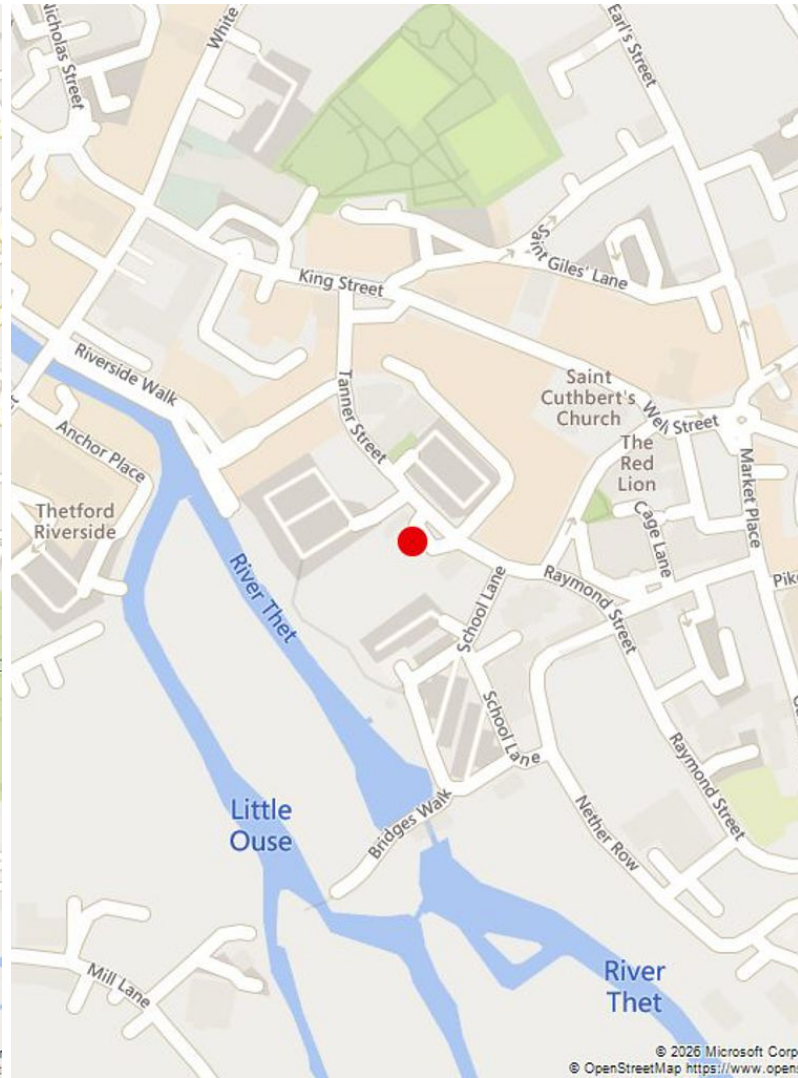
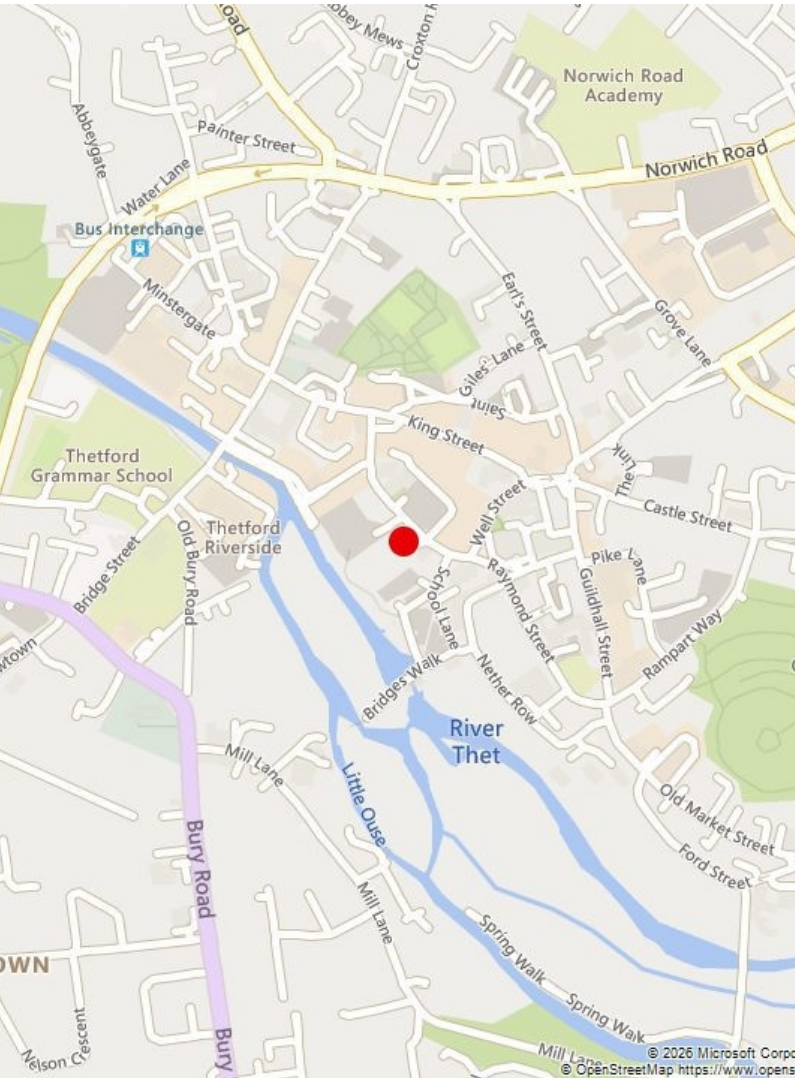
