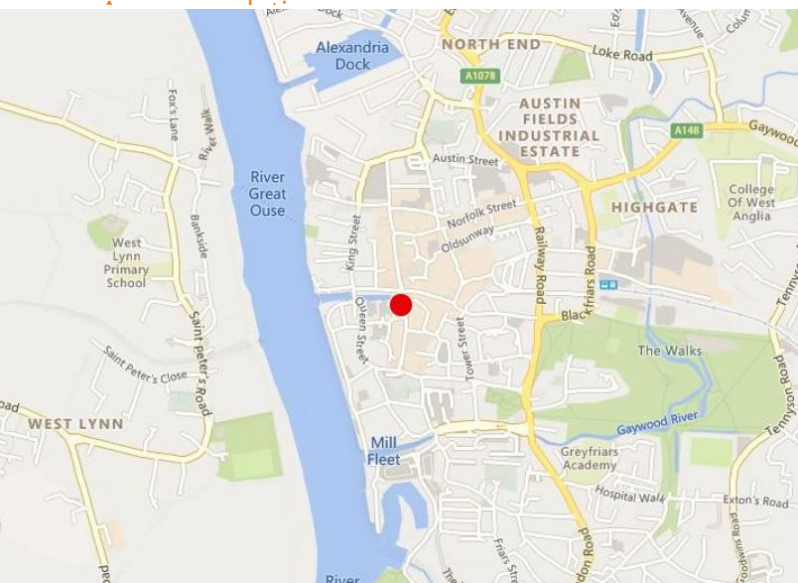

Description
